Our Work



Our education programme provides uniforms, books, exam fees and support for pupils in Waterloo. This year's school leavers have gone on to nursing, vocational school and tailor apprenticeships.





Over 350 women farmers were provided with seeds, tools and protective footwear in order to work the land and provide for their families. This included support for elder women farmers who don't have family to assist them, and food and accommodation for a number of needy recipients, both young and old.

After cleansing

We maintain several wells in Waterloo so that the community can avoid waterborne diseases and be confident of a basic necessity for life: clean water. We provided funding to clean the culverts of debris, washed down from the markets during the floods. Blocked culverts lead to an increase of mosquitoes and malaria: one of Sierra Leone's major causes of ill health and death. This project also provides jobs for the community.

Fatmata's Story

A recent admission to the Education scheme is Fatmata, whose mother died from a malaria-related illness earlier this year, leaving 5 children without a home or schooling.

After a magnificent response to an appeal for help, Fatmata was able to resume her schooling and we were also able house her four siblings for the next two years. This is a letter from Fatmata to all the donors who helped her.

After the death of my mother, who was one of the group leaders in the Women's farmers, my education came to halt because there was no one to pay my fees and support my siblings.

I am now back in school in JSS 2 through the support of Waterloo Partnership. Because I attend school on time and regularly, I am now the class prefect in my class. I am happy to be in school among other children-especially girls- as many do not have the opportunity to attend school.

WP also pays the house rent for my siblings and provides food for them while I stay with a loving guardian who treats me like her child. My sister has now joined the Women Farmers and will be engaged in an economic activity.

I am grateful to the Waterloo Partnership for changing my life and my mother's absence has been filled with a guardian through the support of WP.
